This letter is to inform you that the Onsite Wastewater Product Review Committee has reviewed your application and product sample for the following product categories; *Product Standards for Residential Aerobic Sewage Treatment Units, Standards For High Strength Effluent Reduction and/or Absorption/Dispersal Field Remediation Devices* and *Standards For Bacteriological Treatment Process For Fecal Reduction Using Ultraviolet Light Disinfection*. After careful review the Committee has found that the aforementioned products meet the required standards as previously named

The Committee is hereby placing your products on the authorized product list as a *Residential Aerobic Sewage Treatment Unit* for use with individual onsite wastewater systems. Product authorization may be withdrawn, if in the future, you fail to meet the requirements as found in the above named standards or as set forth in this letter. Any changes in the material composition or manufacturing process, which would alter this product, shall require resubmission to this Committee for reevaluation before said product could be sold or distributed in Arkansas.

According to the information submitted with your requested, the Committee has noted that you Fuji Clean treatment unit does not require the pretreatment or trash tank(s) for proper operation. If in the future any changes that will call for the installation of a pretreatment or trash tank, the Committee shall be notified of said changes with supporting data.

The sale or marketing of residential aerobic sewage treatment unit can only be made through a distributor meeting the requirement found in Appendix F, *Rules and Regulation Pertaining To Onsite Wastewater Systems, Designated Representatives, and Installers*. A list of authorized distributors shall be made available to the Arkansas Department of Health upon request.

A copy of the installation instruction shall be provided to each local health office in the State of Arkansas. The installation instruction shall detail the proper method and techniques for installing and maintaining said product. An electronic version as well as the printed version of said information shall be provided to this Committee.
